## **Rules for Applying**

Rebate applications must be filled out completely and must include receipts showing an item or service purchased in order to be processed.

- 1. Only Farmers Electric Cooperative residential members are eligible for rebates on energy efficiency upgrades.
- 2. The annual rebate cap is \$500 per membership.

SART A. MEMBER INCORMATION

- 3. Applications must be received within the 2023 calendar year.
- **4.** After all program requirements are met and if funds are still available for the Calendar year, a rebate will be issued as a bill credit to the member's account. Please allow up to 8 to 10 weeks after receipt of all documents for the rebate to be processed.
- 5. Farmers Electric Cooperative reserves the right to verify all projects in order to meet minimum program guidelines. The member may lose the rebate if Farmers EC cannot verify the information provided on the application form.
- 6. Submission of an application does not guarantee a rebate; funding for the program is limited. Once funds budgeted for the rebate program are **exhausted**, the program ends. Funding for all previous years is exhausted.
- 7. Purchases must be made in 2023 to qualify.
- 8. No rebates on new home purchases. For residential energy efficiency upgrades only.
