

Thank you for your interest in the Farmers Electric Cooperative, Inc. ("Farmers EC") Rush Hour Rewards Program.

IN ADDITION TO THE TERMS AND CONDITIONS REQUIRED BY GOOGLE, THE RUSH HOUR REWARDS PROGRAM IS OFFERED UNDER THE TERMS AND CONDITIONS SET FORTH IN THIS AGREEMENT ("AGREEMENT") AND ON THE CONDITION THAT YOU ACCEPT AND COMPLY WITH THEM. BY SIGNING UP TO PARTICIPATE IN THE RUSH HOUR REWARDS PROGRAM, YOU: (A) ACCEPT THE TERMS AND CONDITIONS OF THIS AGREEMENT AND AGREE THAT YOU ARE LEGALLY BOUND BY ITS TERMS; AND (B) REPRESENT AND WARRANT THAT YOU ARE OF LEGAL AGE TO ENTER INTO A BINDING AGREEMENT.

The Rush Hour Rewards Program is available only to Farmers EC metered electric members who meet certain eligibility requirements ("Minimum Eligibility Requirements"), which require you to: (1) be a Farmers EC metered electric service account holder; (2) have an 802.11 wireless network at the Farmers EC service address; (3) have an active Nest or Google account linked to your Nest Learning Thermostat at your Farmers EC service address; (4) have an installed and operating Nest Learning Thermostat controlling an HVAC system at your Farmers EC service address; and (5) agree to the terms of this Agreement and any related Google agreement. Farmers EC shall verify your eligibility prior to your participation in the Rush Hour Rewards Program and can deny participation for any reason whatsoever without notice to you.

You are authorizing Farmers EC to share information with Google and other third parties about your energy usage and associated data in order for Google and third parties to evaluate and improve its products and services. Such information includes, but is not limited to, consumption and billing data, billing records, billing history, meter usage data, and rate information. Your credit card, checking account, or similar payment information will not be shared by Farmers EC with Nest or the third parties referenced herein.

You are authorizing Farmers EC to access and utilize certain information (including, but not limited to, your name, email address, service address, Farmers EC account number, Nest Learning Thermostat serial number, activation date, Nest or Google account status, runtime data, setpoints, and related details) to verify that you are eligible to participate in the Rush Hour Rewards Program and to evaluate the comprehensive energy impact of the Nest Learning Thermostat.

A Rush Hour Rewards Program year ("RHR Year") shall be any given year beginning October 1st and continuing through September 30th. Farmers EC members participating in the Farmers Rush Hour Rewards Program agree that the term of participation shall begin on the date of enrollment of your Nest Learning Thermostat and extend for a period of one (1) year ("Initial Enrollment Year"), unless earlier terminated pursuant to the terms herein. The term of this Agreement will be automatically renewed at the end of the Initial Enrollment Year and any other Enrollment Year for an additional period of one (1) year ("Enrollment Year"), unless either party terminates this Agreement.

Within thirty-five (35) days of your approved enrollment for the Rush Hour Rewards Program, you will receive a credit on your electric bill for \$25 ("Enrollment Credit"). For each Enrollment Year after the Initial Enrollment Year that you participate in the Farmers EC Rush Hour Rewards Program, you will receive a \$25 annual participation credit on your electric bill ("Annual Incentive") within thirty-five (35) days from September 30th. Termination of this Agreement prior to September 30 of any RHR Year will result in a forfeiture of the Annual Incentive. Enrollment Credits and Annual Incentives are limited to one Nest Learning Thermostat per service account.

In the event you terminate your enrollment in the Rush Hour Rewards Program, you will be ineligible to receive an Enrollment Credit for any future participation in the Rush Hour Rewards Program. Upon your re-enrollment in the program for a subsequent RHR Year and your meeting of eligibility and participation requirements, you will be eligible to receive any otherwise eligible Annual Incentive.

You represent and warrant that the information you have provided as part of this Agreement is truthful and you meet the Minimum Eligibility Requirements. You further agree that Farmers EC may terminate this Agreement, refuse to enroll you, or terminate your enrollment in the Rush Hour Rewards Program if you are not truthful in the information you submit as part of this Agreement, if you do not satisfy eligibility requirements, or for any other reason whatsoever, with or without notice to you. Farmers EC may modify the Agreement terms at any time, with the most current terms being available on Farmers EC website. You agree that you are participating in the Rush Hour Rewards Program on a voluntary basis and continued participation in the Program signifies acceptance of then-current Agreement terms.

**YOU RELEASE AND HOLD HARMLESS GOOGLE AND FARMERS EC FROM ANY LIABILITY, CLAIM, DEMAND, CAUSE OF ACTION, DAMAGE OR EXPENSE RESULTING FROM OR IN ANY WAY CONNECTED WITH YOUR PARTICIPATION IN THE RUSH HOUR REWARDS PROGRAM.**
